Most applications have been approved enabling people to build extensions or make alterations to their property. Not all applications go smoothly however, and I would strongly advise people wanting to put in an application to talk to the Parish Council who make comments pertinent to each application. It is worth having pre-application advice from Planning Officers. I am also readily available to discuss any individual plans with anyone in the village and I frequently act as a go-between between resident and Planning Officer to try to resolve any problems on an informal basis.

## **Issues raised by the Community**

Many of the issues have been highway issues which the Suffolk County Councillor addresses. There has been concern raised about the speeding of the traffic and the very large lorries using the roads through the villages and not the directions diversion routes when the A14 has been having refurbishing work carried out overnight. Fly tipping Speeding traffic through the villages Maintenance of public rights of way Dog fouling Flooding has been a big issue Public footpaths overgrown with weeds Motor bicycles and 4x4 using byways as racing tracks The use of the byways by 4x4's and motor bikes Flooding has been a major problem with need for better management of ditches and drains being maintained to deal with the excessive water.

# Highlights from West Suffolk 2023-2024

The elections in May 2023 resulted in a change to the administration of the West Suffolk council from Conservatives led council to a coalition formed between the Labour and Independents.

The new administration took the decision to cancel the Western Way project which was to provide a new leisure centre and swimming pool and a day care nursery and house the records office. They have opted to carry out the necessary repairs to the existing swimming pool.

A grounds maintenance review was carried out in the Autumn. As agreed by Council as part of the budget process we have been able to increase our grass cutting capacity this coming season following the grounds maintenance review. This means increased capacity in terms of staff and resources in both the North and South of the District.

## The use of Glyphosate

Following the ban of using Glyphosate by West Suffolk Council and Suffolk County Council the control of weeds was a very big problem with many complaints of the state of the areas being overgrown with weeds.

SCC Highways took the decision to reinstate its use of Glyphosate weed control from 01 April 2024 earlier this year on the basis that nothing else they have trialled works anywhere near as effectively.

# Work on the next local plan for 2024 - 2040

The final consultation closed on the 12th March 2024 with over 1,000 responses this is the technical and legal consultation. All the responses will be recorded, and the submission consultation document and evidence base will be submitted to the Secretary of State for the independent examination which will be carried out late in 2024. In Spring 2025 there will be a modification consultation. It is envisaged that the new West Suffolk local plan will be adopted in Spring 2025.

# Creation of a Decarbonisation Initiatives fund of a £1 million

The first call on the fund is a grant scheme for the upgrading of streetlights owned by the town and parish councils to LED lanterns. After this scheme is completed the remaining balance of the fund will be for additional decarbonisation initiatives.

# Local tax reduction scheme

This scheme will be extended for another year from the 1st April 2024. This is a means tested scheme that aims to support residents in financial hardship in light of the cost of living crisis. The reduction is a 100% on the Council tax reduction scheme and lasts for one year only.
